How did the Fund perform last year and what affected its performance?

Class R6 shares of GMO Emerging Markets Fund returned +2.91% (net) for the fiscal year ended February 28, 2025, as compared with +10.07% for the MSCI Emerging Markets Index.

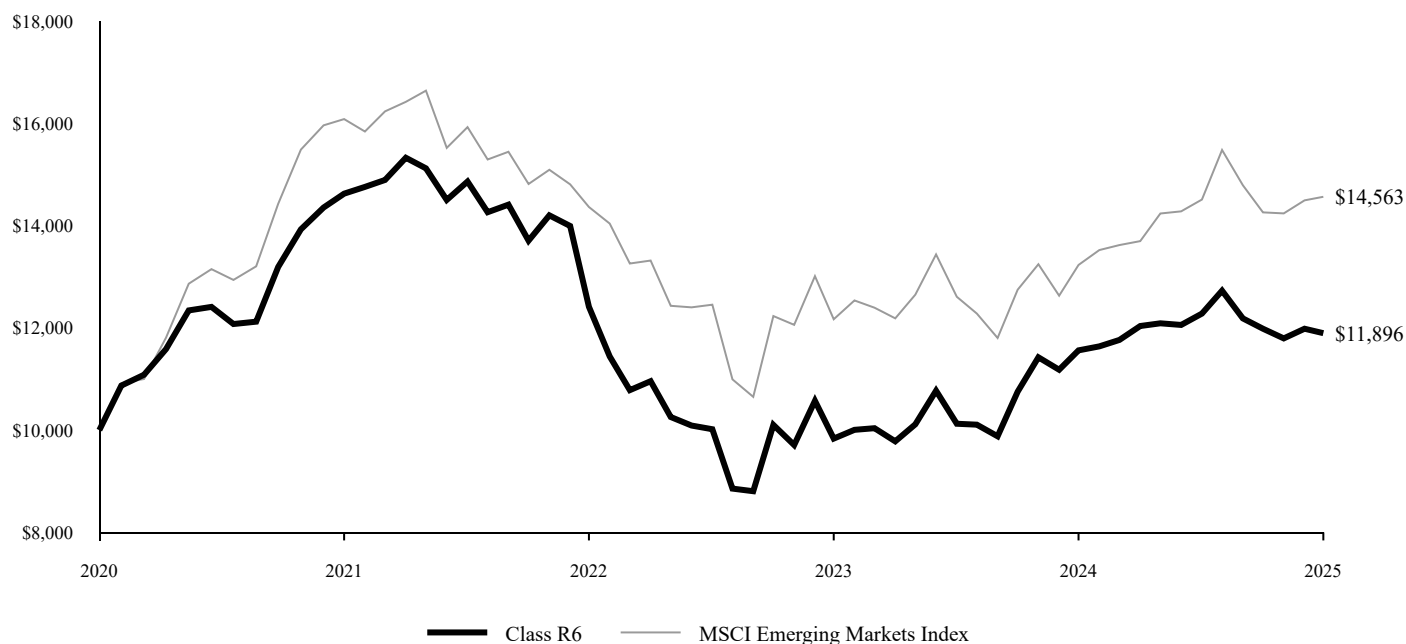
China was the largest detractor from a mix of underweight country allocation and stock selection, including underweight positioning toward Consumer Discretionary, Communication Services, and Information Technology. Sector allocation was also a challenge, including overweight positioning toward Energy.

Decisions which added to benchmark relative performance included stock selection in Industrials and Consumer Staples. Underweight positioning toward Korean Information Technology also added value.

The net expense ratio of 0.97% reflects the reduction of expenses from fee reimbursements. The fee reimbursements will continue until at least June 30, 2025 and may not be terminated prior to this date without the action or consent of the Trust's Board of Trustees. Elimination of this reimbursement will result in higher fees and lower performance.
