How did the Fund perform last year and what affected its performance?

Although the Fund is not managed relative to any securities market index or benchmark, a discussion of the Fund's performance relative to the MSCI World ex USA Value Index is included for comparative purposes.

Class III shares of GMO International Opportunistic Value Fund returned +16.23% (net) for the fiscal year ended February 28, 2025, as compared with +15.64% for the MSCI World ex USA Value Index.

Stock selection within sectors drove portfolio outperformance for the period with notable contributions from Financials in Spain, the UK, and France.

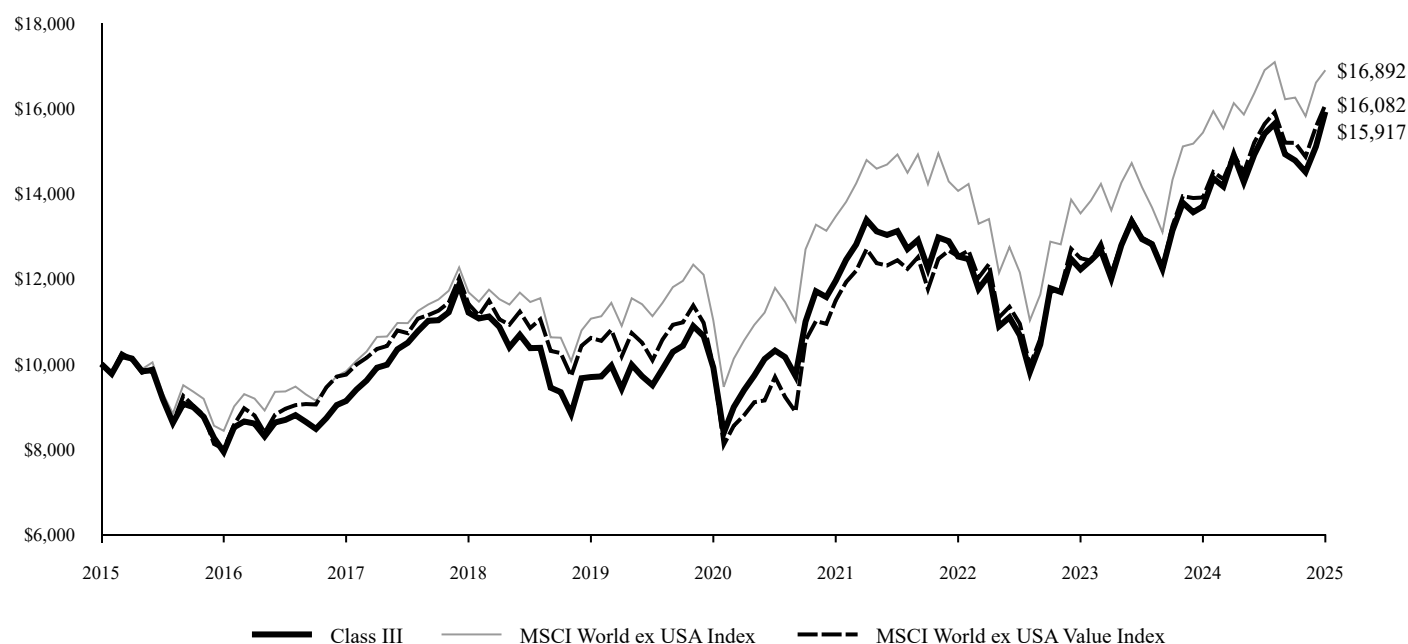
Decisions which detracted from performance included overweight positioning in automobile manufacturers and stock selection within Japan and Materials.

The net expense ratio of 0.68% reflects the reduction of expenses from fee reimbursements. The fee reimbursements will continue until at least June 30, 2025 and may not be terminated prior to this date without the action or consent of the Trust's Board of Trustees. Elimination of this reimbursement will result in higher fees and lower performance.
