## How did the Fund perform last year and what affected its performance?

Although GMO does not manage the Fund to, or control the Fund's risk relative to, any securities index or securities benchmark, a discussion of the Fund's performance relative to the MSCI All Country World Index ("ACWI") Commodity Producers Index is included for comparative purposes.

Class I shares of GMO Resources Fund returned -12.96% (net) for the fiscal year ended February 28, 2025, as compared with +2.45% for the MSCI ACWI Commodity Producers Index.


The Fund's energy portfolio delivered negative absolute returns. The underweight to fossil fuel producers and off-benchmark position in clean energy also led to underperformance versus the benchmark, as the clean energy sector continued to come under pressure. Two energy names, Kosmos and SolarEdge, that were part of the fossil fuel and clean energy sectors respectively, were the two biggest relative detractors.

The Fund's agriculture portfolio delivered diversifying stronger performance and added the most relative return.
