How did the Fund perform last year and what affected its performance?

Although the Fund is not managed relative to any securities market index or benchmark, a discussion of the Fund’s performance relative to the S&P Composite 1500 Index is included for comparative purposes.

Class VI shares of GMO U.S. Equity Fund returned +14.44% (net) for the fiscal year ended February 28, 2025, as compared with +17.55% for the S&P Composite 1500 Index.

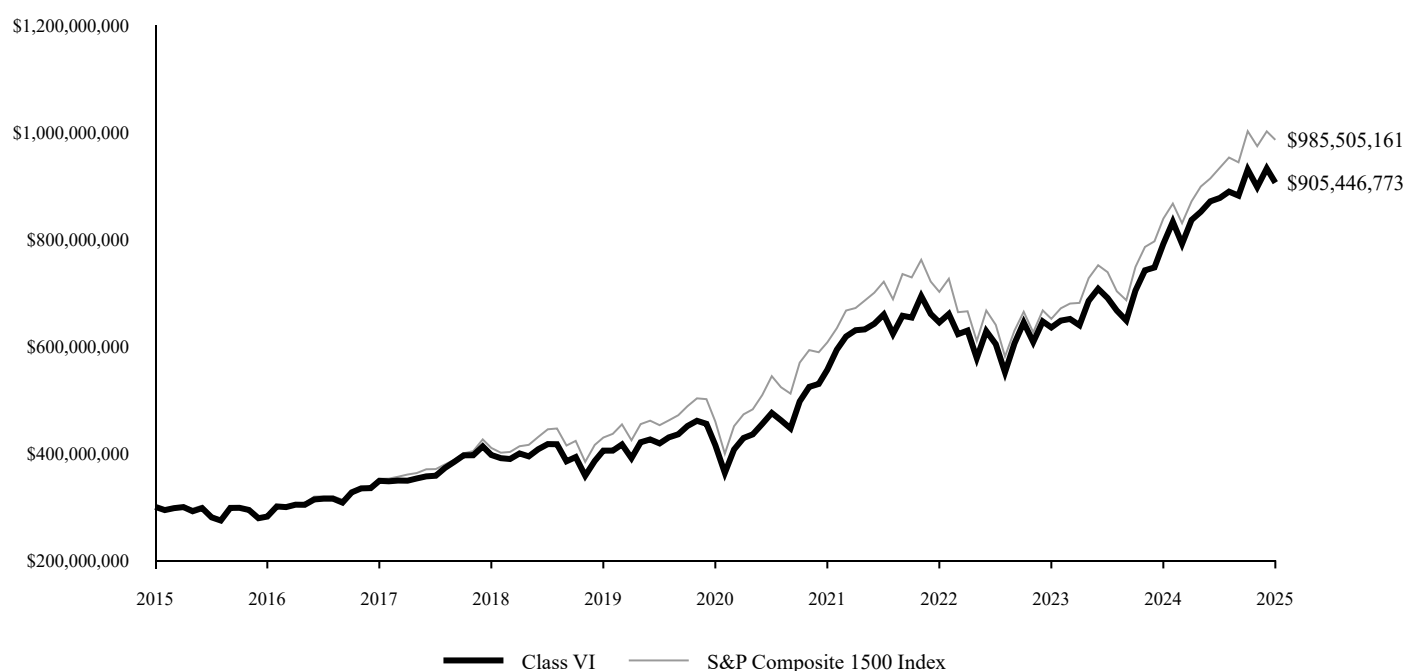
The bulk of the underperformance for the period was driven by stock selection within Information Technology, Industrials, and Health Care, with several top detractors related to semiconductors and semiconductor equipment.

Areas of value added included a mix of overweight allocation and stock selection in Financials, as well as stock selection in Energy and Consumer Discretionary.

The gross expense ratio of 0.44% for Class VI is equal to the Total Annual Operating Expenses set forth in the Fund's most recent prospectus dated June 30, 2024. The net expense ratio of 0.39% reflects the reduction of expenses from fee reimbursements. The fee reimbursements will continue until at least June 30, 2025 and may not be terminated prior to this date without the action or consent of the Trust's Board of Trustees. Elimination of this reimbursement will result in higher fees and lower performance.
