#### Investment Review: Quarter Ending December 31, 2022

#### **OVERVIEW**

The GMO Emerging Domestic Opportunities Fund's investment objective is total return. The Fund begins with country and sector allocation and then uses fundamental analytical techniques to select individual companies whose prospects are linked to the internal ("domestic") development and growth of the world's non-developed markets ("emerging markets").

#### Major Performance Drivers

Emerging market equities posted a big quarter on the back of a jump in positive sentiment in China. Country returns varied, ranging from a 15.3% fall in Qatar to a 62.9% leap in Turkey. Sector returns were more clustered, varying from an increase of 4.2% in Energy to a rise of 13.8% in Communication Services.

Brazilian equities began the quarter well, boosted by a smooth election and expectations of a centrist policy from the new administration. Later in the period, they retracted when confronted by the size of the incoming government's spending plans. Our underweight in Brazil Financials contributed to performance.


Sentiment in China initially took a hit as the focus of the country leadership was seen moving away from economic reform and toward geopolitical issues. The market turned around later as the government relaxed its zero Covid policy and announced a plan to support the property sector. Our overweight in China Industrials helped performance.

The stock market in India dropped as concern grew over expensive valuations, rising rates, and weakening global demand. Our overweight in India Consumer Discretionary detracted from performance.

Reports of above expected economic expansion boosted investor sentiment in Mexico. Toward the end of the quarter, sentiment took a hit from a proposed reform that was seen as weakening the power of the election commission. Our overweight in Mexico Financials added to performance.
