Quarterly Investment Review

PRODUCT OVERVIEW

The GMO International Opportunistic Value Fund seeks to generate total return by investing primarily in international equities. The Fund measures its performance against the MSCI World ex-U.S.A. Value Index.

The Fund aims to profit from our Asset Allocation team's top-down insights as to the most attractively valued segment of developed markets outside the U.S. Currently, the team finds developed, non-U.S. "deep value" (cheapest 20%) stocks to be unusually cheap relative to their own history. This actively managed Fund concentrates exposure in the deep value segment by focusing on the international stocks that GMO's Systematic Equity team identifies as the most undervalued, using proprietary valuation models because we believe that relying on reported financials and index definitions of value may lead investors to misjudge the opportunity.

MAJOR PERFORMANCE DRIVERS

Global equity markets continued to deliver positive absolute returns across regions amid enthusiasm for AI infrastructure and strong outperformance from the Information Technology sector. This market strength persisted despite ongoing disruptions in the trade of energy, commodities, and other critical products from the Middle East. In this environment, the Energy sector underperformed after having rallied in March amid the Iran conflict.

In the second quarter, MSCI World ex USA Value underperformed MSCI World ex USA Growth, and stocks we identified as deep value underperformed their shallow value peers. In this environment, the portfolio's deep value orientation drove underperformance.

Deep value stock selection in Japan, and a mix of allocation and selection decisions in Information Technology and Energy were the largest detractors. The bulk of the Information Technology underperformance was from deep value stock selection, with the biggest area of underperformance from Japanese Information Technology. Given the broader market dynamics, the portfolio's overweight positioning in Energy detracted, but the underperformance was compounded by deep value stock selection.

Areas of strength for the portfolio's deep value orientation included stock selection in Financials, with notable contributions from overweight positions in Canadian and French Financials. In contrast to other challenges in Japan, Japanese Consumer Discretionary was an area of strength, including overweight positioning in top contributor, Panasonic Holdings.

Portfolio weights, as a percent of equity, for the positions mentioned were: Panasonic Holdings (0.7%)
