## GMO Resources UCITS Fund - a sub-fund of GMO Investments ICAV Class A SGD (ISIN: IE00BLR75050)

### Objectives and Investment Policy

The fund's investment objective is to seek total return.

The fund invests in equities (shares) of companies in the natural resources sector, namely companies that own, produce, refine, process, transport, and market natural resources and companies that provide related equipment, infrastructure, and services. In addition to its investments in companies in the natural resources sector, the fund also may invest up to 20 per cent. of its net assets in securities of any type of company. The investment adviser selects the securities the fund buys and sells based on its evaluation of companies' published financial information and corporate behaviour, sustainability and other ESG criteria, securities' prices, commodities' prices, equity and bond markets, the overall global economy, and governmental policies. The factors considered and models used by the investment adviser may change over time.

The fund may invest in a wide range of assets, including long and short positions in equities (shares) and related securities, debt securities, money market instruments, currencies, interest rates, and derivatives. A long position will increase in value if the price of the underlying asset goes up; a short position will increase in value if the price of the underlying asset goes down; and vice versa. Such assets may be located, listed or traded anywhere in the world, may have any market capitalisation. The fund may also invest in other investment funds.

The fund may invest in debt securities which may include investment grade, non-investment grade and unrated debt securities of any credit quality and having any maturity or duration. Such debt securities may be supranational, government

or corporate securities and may be fixed or floating rate securities.

The fund may use instruments whose value is determined by changes in the value of the underlying assets they represent (derivatives). Derivatives may be used for investment purposes and for the reduction of risk and cost and the generation of additional capital or income.

The fund is actively managed and does not manage the fund to, or control the fund's risk relative to, any securities index or securities benchmark. The fund uses the MSCI AC World Index and MSCI ACWI Commodity Producers Index for performance comparison purposes only (together, the "Comparator Indices"). Although the fund's securities may be components of the Comparator Indices, the investment adviser may or may not invest in securities not included in the Comparator Indices.

You may sell your shares usually on each business day (generally, a day on which banks in Dublin and London and the New York Stock Exchange are open) by sending your request to State Street Fund Services (Ireland) Limited before 2.00 pm (Irish time) on the preceding business day.

Income is reinvested into the fund.

The numerical scale is complex. For example, 2 is not twice as risky as 1. The gap between 1 and 2 might not be the same as the gap between 5 and 6. A category 1 fund is not a risk-free investment – the risk of losing your money may be small, but the chance of making gains is also limited.

The fund is in category 7 because it has a focused investment strategy. Historically there has been a greater fluctuation in the price of shares of such funds than other funds (such as money market funds).

#### Risks materially relevant to the fund which may not be adequately captured by the indicator:

The fund may not achieve its investment objective and the value of shares in the fund may fall. The market price of a security may decline due to factors affecting the issuer, its industry or the economy and markets generally.

Because the fund concentrates its investments in the natural resources sector, the fund will be more susceptible to events or factors affecting these companies, and the market prices of its portfolio securities may be more volatile than those of funds that are more diversified.

Geopolitical and other events may disrupt markets and adversely affect global economies and markets. Those events as well as other changes in economic and political conditions could adversely affect the value of the fund's investments.

Low trading volume, lack of a market maker, large size of position or legal restrictions may limit or prevent the fund from selling securities or closing derivative positions at desirable prices.

The market price of debt securities can decline due to market-related factors, including rising interest rates and widening credit spreads (i.e., the difference in yield between debt securities with different credit ratings), or decreased liquidity stemming from the market's uncertainty about the value of such debt securities.

The use of derivatives involves the risk that their value may not move as expected relative to the value of the relevant underlying assets, rates or indices.
