What is this product?

Type GMO Funds plc is an open-ended investment company with variable capital and segregated liability between sub-funds.

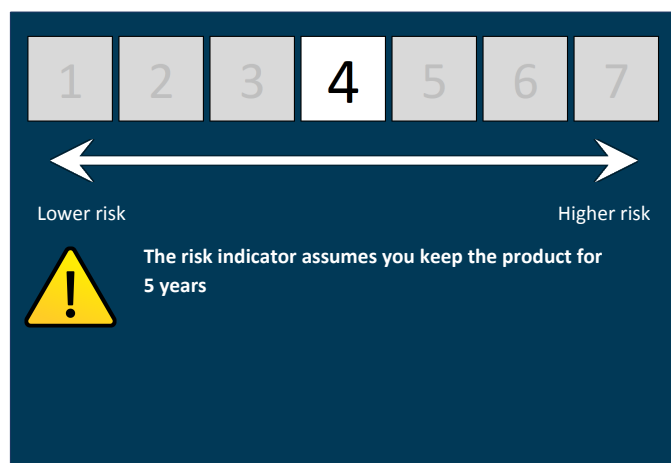
Investment objective and policy

The fund aims to achieve positive returns. The fund will invest primarily in shares and related securities which are listed or traded on markets globally. The fund identifies investment opportunities based on an analysis of companies' published financial information and corporate behaviour, securities' prices, equity and bond markets and the overall economy. Investments are selected using a combination of investment methods to identify investments that the investment manager believes present positive return potential relative to other securities in the fund's investment universe. The fund may use instruments whose value is determined by changes in the value of the underlying assets they represent (derivatives). Derivatives may be used for the reduction of risk and cost and the generation of additional capital or income. The fund is actively managed and does not manage the fund to, or control the fund's risk relative to, any securities index or securities benchmark. The fund uses the MSCI AC World Index for performance comparison purposes only (the "Comparator Index"). Although the fund's securities may be components of the Comparator Index, the fund's investment manager may or may not invest in securities not included in the Comparator Index. You may sell your shares usually on each business day (generally a day on which banks in Dublin and London and the New York Stock Exchange are open) by sending your request to State Street Fund Services (Ireland) Limited before 2.00 pm (Irish time) on the preceding business day. This document describes a sub-fund of the fund. The prospectus and periodic reports are prepared in respect of the entire fund. Each investor of the fund may apply to exchange shares in the fund for shares in another sub-fund of the fund as set out in the prospectus.

What are the risks and what could I get in return?
