

Additional Information for Investors resident in the Republic of Austria

This country supplement contains additional information for investors resident in the Republic of Austria relating to GMO SGM Major Markets Investment Fund, GMO Climate Change Investment Fund and GMO Resources UCITS Fund (each a "**Fund**" and collectively the "**Funds**"), sub-funds of GMO INVESTMENTS ICAV, an Irish collective asset-management vehicle with registration number C155870 authorized in Ireland in the form of an umbrella fund with segregated liability between its sub-funds. **This country supplement forms part of, and should be read in conjunction with, the latest published version of the prospectus dated 12 January 2022, as supplemented from time to time (the "Prospectus").** Unless otherwise stated, all defined terms in this country supplement shall have the same meaning as in the Prospectus.

Right to public marketing in Austria

The ICAV has notified the Austrian Financial Market Authority (*Finanzmarktaufsicht*; "**FMA**") of its intention to publicly market certain share classes in the Funds in Austria in accordance with § 140 (1) of the Austrian Investment Funds Act 2011 (*Investmentfondsgesetz 2011, InvFG 2011*).

Since completion of the notification process the ICAV has the right to publicly market those shares in Austria.
