MAJOR PERFORMANCE DRIVERS

The J.P. Morgan EMBI Global Diversified (EMBIG-D) benchmark returned 4.8% for the period, with a year-to-date return of 10.7%. The index's spread over Treasuries tightened by 39 bps, ending the period at 284 bps, resulting in a spread return of 3.2%. Meanwhile, the 10-year Treasury yield fell by 8 bps, finishing at 4.15%, contributing to an interest rate return of 1.5%.

The portfolio experienced positive alpha from both country selection and security selection during the period. Notably, an overweight position in Venezuela (+21.5%) contributed positively to country selection alpha, as did overweights in Colombia (+9.5%), Lebanon (+17.2%), and Kenya (+9.8%). An underweight position in Indonesia (+3.0%) also contributed positively. Conversely, an overweight position in Argentina (-17.7%) detracted from performance, offsetting some of the gains from other countries.

Security selection alpha was positive and was significantly impacted by holdings within in-index countries, with Argentina, Mexico, and Peru contributing positively, while Brazil was a major detractor. Among out-of-index countries, the Republic of Congo and Tunisia contributed positively, offsetting negative impacts from holdings in Israel and Belarus. In the quasi-sovereign category, Peru and Mexico were top contributors, while Brazil was the largest detractor.

At the end of the period, the portfolio's largest overweights are Venezuela, Mexico, and Turkey, while the largest underweights are China, Indonesia, and Malaysia. During the period, the portfolio's position in Qatar went from underweight to neutral as the country exited the index, while Mexico and Venezuela saw increases in their overweight positions. Conversely, the Dominican Republic and Oman shifted from overweight to underweight positions, and Egypt experienced a decrease in its overweight position.

PRODUCT OVERVIEW

The GMO Emerging Country Debt Strategy's objective is total return in excess of that of its benchmark, the J.P. Morgan Emerging Markets Bond Index Global Diversified (EMBIG-D). The Strategy invests primarily in external debt of sovereigns and quasi-sovereigns.

GMO's Emerging Country Debt team focuses on bottom-up issue selection, seeking to find issues with similar default characteristics but better long-term total return potential than the issues in EMBIG-D. We believe that our approach provides value-oriented clients with long-term investment objectives a significantly higher likelihood of outperforming the EMBIG-D than the approaches employed by other emerging debt managers who focus on economic forecasting, market timing, and other macro/top-down approaches.
