MAJOR PERFORMANCE DRIVERS

The J.P. Morgan GBI-EM Global Diversified Index + (GBI-EMGD) returned 7.62% during the second quarter of 2025. Local bond performance was positive (3.2%, with returns of 2.8% when hedged into U.S. dollars), while spot currency performance was also positive (4.3%). The comparable figures for foreign developed market bonds were also positive in the second quarter, with 1.1% for local bonds (1.7% hedged), and spot FX performance of 6.4%. The dollar weakened against other major currencies in Q2, and emerging market exchange rates also strengthened against the dollar.

The portfolio outperformed the benchmark in the second quarter, with the portfolio deriving positive alpha from interest rate market selection, security selection, and other portfolio attributes. In interest rate market selection, the portfolio's overweight positions in Brazil (6.5% total local return), South Africa (5.9%), Indonesia (3.4%), and Mexico (3.2%) added the most to alpha during the quarter. While unable to fully offset gains, underweight positions in Thailand (3.1%) and Poland (2.8%) and overweight position in Romania (1.3%) detracted from alpha.

MAJOR PERFORMANCE DRIVERS CONT.

Currency selection performance was positive during the quarter. The most notable contributors to positive alpha were our portfolio's overweight positions in the Brazilian real, the Turkish lira, the Dominican peso, and underweight position in Hungarian forint, as well as an off-benchmark long position in the Japanese yen. The portfolio's underweight positions in the Polish zloty, Chilean peso, and the Serbian dinar, as well as an off-benchmark short position in the Singapore dollar and Taiwanese dollar, were notable negative contributors to currency alpha, but less than offset some of the currency losses.

Instrument selection and other portfolio attributes added to alpha over the quarter, primarily driven by the positive impact from currency residuals arising from the index (London) versus the portfolio (New York). Instrument selection was positive over the quarter. Mexico, Romania, and Chile were the most notable on-benchmark country contributors in this category. The choice of off-benchmark holdings in Israel, Argentina, Egypt, and Nigeria also contributed positively during the quarter. Gains were partly offset by losses given the choice of holdings in China, Poland, Brazil, and off-benchmark holdings in Venezuela.

Entering the third quarter of 2025, the portfolio's largest currency active weights are the Colombian peso, Brazilian real, Japanese yen, Turkish lira, and the Egyptian pound on the positive side, and Singapore dollar, Chinese yuan, Polish zloty, Indian rupee, and Taiwanese dollar on the negative side. The largest positive interest rate active weights are in South Africa, Mexico, Indonesia, Czech Republic, and Chile, while the largest negative ones are in Thailand, South Korea, India, China, and Israel.

The GMO Emerging Country Local Debt Strategy's objective is total return in excess of its benchmark, the J.P. Morgan Government Bond Index - Emerging Markets Global Diversified (GBI-EMGD). The Strategy invests in local currency emerging debt.

GMO's Emerging Country Debt team focuses on bottom-up issue selection within sovereign and quasi-sovereign issuers with an emphasis on finding fundamental value, also employing advanced quantitative techniques to assess value across global emerging and frontier interest rate and currency markets. We believe that our approach provides our clients with the best chance for long-term success in this asset class and differentiates us from other emerging debt managers who focus on top-down timing elements.
