MAJOR PERFORMANCE DRIVERS

– Top-down asset allocation significantly contributed to relative performance for the quarter as, within Developed Markets, the portfolio is biased away from the U.S. market, which badly underperformed. It was also a solid quarter for Emerging Markets.

– Security selection was also strongly positive in Developed Markets, as a combination of Quality and Value performed well.

Emerging market equities, with an emphasis on undervalued stocks within attractively valued countries/sectors, represented 13.3% of the total portfolio weight on average during the quarter. Our modest overweight position in Emerging Markets added marginally to relative performance as the MSCI Emerging Market index returned 2.9%, nicely ahead of the MSCI ACWI return of -1.3%. Security selection was a little negative, as the portfolio underperformed with a return of 1.6%. An overweight position in TSMC (Taiwan Information Technology) featured in the top five biggest individual detractors from relative performance at the total portfolio level, while no Emerging Market names featured in the top five biggest individual contributors.

MAJOR PERFORMANCE DRIVERS CONT.

U.S. equities accounted for 40.5% of the total portfolio on average through the quarter, comprising 2.8% in U.S. Small Cap Value equity, 4.8% in U.S. Small Cap Quality equity, 7.0% in broad U.S. equity, 13.0% in U.S. Opportunistic Value equity, and the remainder in the Quality, Quality Cyclical, and Resources strategies. This leaves the portfolio 25.2% underweight U.S. equities in total, and this had a positive impact on relative performance for the quarter as the MSCI USA index returned -4.6%, trailing MSCI ACWI. Security selection in the U.S. was solid as, in aggregate, our U.S. portfolio returned -3.7%. We removed the exposure to Quality Cyclical toward the end of the quarter. Underweight positions in Tesla (Consumer Discretionary), NVIDIA (Information Technology), Broadcom (Information Technology), Microsoft (Information Technology), and Apple (Information Technology) made up the top five biggest individual contributors to relative performance for the quarter. On the flipside, underweight positions in AbbVie (Health Care), Philip Morris (Consumer Staples), and Berkshire Hathaway (Financials) featured in the top five biggest individual detractors from relative performance at the total portfolio level.

Developed ex-U.S. equities accounted for an average weight of 45.0% of the portfolio for the quarter, including the dedicated Japan Value position and some exposure from the Quality, Resources and Quality Cyclical strategies. This overweight position in Developed ex-U.S. had a positive impact on relative performance as the MSCI World ex-U.S. index returned 6.2%, well ahead of MSCI ACWI. Security selection within Developed Markets was strong for the quarter and the portfolio returned 8.4% in aggregate. As noted above, we removed the exposure to Quality Cyclical toward the end of the quarter. An overweight position in Recruit Holdings (Japan Industrials) featured in the top five biggest individual detractors, while no Developed ex-U.S. names featured in the top five biggest individual contributors to relative performance for the quarter.

Portfolio weights, as a percent of equity, for the positions mentioned were: TSMC (1.5%), Berkshire Hathaway (0.0%), Broadcom (0.0%), Tesla (0.0%), Apple (1.1%), Philip Morris (0.0%), NVIDIA (0.3%), AbbVie (0.0%), Microsoft (1.0%), and Recruit Holdings (0.5%).

PRODUCT OVERVIEW

The Strategy seeks to generate total return greater than that of the MSCI All Country World Index.

The philosophy that underlies all of GMO's Asset Allocation investment strategies is the belief that, at times and in the short term, the pricing of asset classes can deviate from true intrinsic value, but mean reverts to appropriate valuation levels over the long term. Using GMO's 7-Year Asset Class Forecasts, the Strategy seeks to allocate to areas of the global equity markets we believe are most attractively valued. Our approach combines the best of GMO's top-down Asset Allocation views and bottom-up equity research to identify mispricings at both the asset class and individual security levels. The Strategy allocates to equity strategies that are actively managed by other GMO investment teams with expertise and experience in security selection within their respective markets.
