MAJOR PERFORMANCE DRIVERS

- Top-down asset allocation was broadly flat for the quarter.
- Security selection was positive, with good performance in equities, alternative strategies, and emerging debt.

Equities represented 63.1% of the portfolio on average through the quarter, with 6.1% in Emerging Markets, 3.1% in Emerging Markets ex-China, 15.1% in Developed ex-U.S., 3.0% in Quality, 8.1% in U.S., 1.9% in U.S. Small Cap Value, 3.0% in U.S. Small Cap Quality, 7.0% in U.S. Opportunistic Value, 6.1% in Japan Fundamental Value, 7.1% in International Opportunistic Value, and 2.7% in Resources equity.

The equity portfolio returned 8.1% for the quarter, ahead of the MSCI ACWI return of 7.6%. Top-down regional and stylistic exposures had a limited impact as the U.S. outperformed developed ex-U.S., but this was offset by value doing well outside of the U.S., coupled with the strong performance of emerging markets.

Security selection was positive for the quarter. The Emerging Markets portfolio returned 10.3%, which was 30 bps behind the MSCI Emerging Markets Index, and Emerging Markets ex-China returned 6.3%, which was 30 bps behind the MSCI Emerging Markets ex-China Index return of 6.6%. In Developed ex-U.S. markets, the portfolio posted 6.5%, which was 120 bps ahead of the MSCI World ex-USA Index, and International Opportunistic Value posted 8.7%, outperforming the MSCI World ex-USA Value Index by 80 bps. In the U.S., the broad U.S. portfolio return of 10.1% beat the S&P Composite 1500 by 210 bps, while the U.S. Opportunistic Value return of 5.8% outperformed the MSCI USA Value Index by 60 bps. Quality lagged the S&P 500 by 290 bps. U.S. Small Value and Resource equity outperformed their reference benchmarks, while U.S. Small Quality underperformed. The Japan Value portfolio returned 8.2% and was behind the TOPIX by 20 bps. Being very slightly underweight to equities had no material impact on performance against the asset allocation benchmark.

QUARTERLY INVESTMENT REVIEW

MAJOR PERFORMANCE DRIVERS CONT.

Alternative strategies averaged 13.0% through the quarter, which was all invested in the Alternative Allocation Strategy. The Alternative Allocation Strategy posted a return of 4.3% for the quarter, behind the return of world equities but decently outperforming bonds. Within the Alternative Allocation strategy, Equity Dislocation, Systematic Global Macro, and Event-Driven were the biggest contributors to performance. Our exposure to alternatives had a small negative impact on relative performance as they modestly underperformed the asset allocation benchmark.

Fixed income represented 21.9% of the portfolio on average through the quarter, including 0.9% in Asset-Backed Securities, 3.1% in Emerging Country Debt, 11.9% in the Multi-Sector Fixed Income Strategy, and 6.0% in U.S. Treasury Notes. Our fixed income strategies returned 2.8% for the quarter, ahead of the Bloomberg U.S. Aggregate return of 2.0%. Asset-Backed Securities returned 1.7%, while Multi-Sector Fixed Income delivered 2.2%, and U.S. Treasury Notes posted 2.1%. Our Emerging Country Debt portfolio returned 6.9%, which was ahead of the EMBI Global Diversified Index return of 4.8%. Our underweight exposure to fixed income had a positive impact on performance relative to the asset allocation benchmark.

PRODUCT OVERVIEW

The GMO Global Asset Allocation Strategy seeks to achieve a total return greater than that of its benchmark of 65% MSCI All Country World Index and 35% Bloomberg U.S. Aggregate Index, over a complete market cycle, by allocating dynamically across asset classes.

The philosophy that underlies all of GMO's Asset Allocation investment strategies is the belief that, at times and in the short term, the pricing of asset classes can deviate from true intrinsic value, but mean reverts to appropriate valuation levels over a complete market cycle. GMO's proprietary 7-Year Asset Class Forecasts form the foundation of our investment process, providing a framework to assess the return opportunity embedded in different asset classes. We use that insight to allocate to what we believe are the most attractively priced asset classes. We also seek to add value through security selection within both traditional and alternative asset classes.
