### MAJOR PERFORMANCE DRIVERS

- The portfolio is now reasonably aligned with the benchmark from a top-down regional perspective. The portfolio does have a notable overweight to Japan, and this had a small negative impact for the quarter as MSCI Japan underperformed MSCI ACWI ex USA.
- Security selection was strong as there was good outperformance in both developed and emerging markets.

Emerging market equities, with an emphasis on undervalued stocks within attractively valued countries and sectors, represented 29.6% of the total portfolio weight on average during the quarter. This represents a modest underweight in emerging market equities, which added marginally to relative performance as the MSCI Emerging Markets Index returned 4.7%, lagging the MSCI ACWI ex USA return of 5.1%. Security selection was solid, as the portfolio returned 6.0%. An overweight position in Phison Electronics (Taiwan Information Technology) and an underweight in Alibaba Group (China Consumer Discretionary) featured among the top five biggest individual contributors to relative performance, while an underweight position in SK Hynix (Korea Information Technology) featured among the top five biggest individual detractors for the quarter.

This event contributed 2.51% to 2024 annual performance, based on a representative account. Performance for other periods, including this date, was also positively impacted, sometimes materially. Without this recovery, performance would have been lower in both absolute terms and relative to the benchmark. Additional information is available upon request. Returns reflect a significant, one-time increase to the net assets on November 26, 2025 attributable to European Union discriminatory tax refunds. These refunds contributed 2.34% to 2025 annual performance, based on a representative account. Returns for other periods that include the date/period mentioned above were also positively impacted, sometimes substantially. In the absence of the refunds, performance would have been lower, both in absolute terms and relative to the benchmark. Additional information is available upon request.

# QUARTERLY INVESTMENT REVIEW

## MAJOR PERFORMANCE DRIVERS CONT.

Developed ex-U.S. equities accounted for an average weight of 69.1% of the portfolio for the quarter, including the dedicated Japan Value position. The portfolio was broadly neutral in developed ex-U.S. equities, and this had no impact on relative performance. Security selection was strong, as the portfolio returned 6.9% versus the MSCI World ex-USA Index return of 5.2%. Overweight positions in Nokia (Finland Information Technology), Banco Bilbao (Spain Financials), and Sumitomo Electric (Japan Consumer Discretionary) featured among the top five biggest individual contributors, while an underweight position in AstraZeneca (United Kingdom Health Care), and overweight positions in Bandai Namco (Japan Consumer Discretionary), 3i Group (United Kingdom Financials), and Prosus (Netherlands Consumer Discretionary) featured among the top five biggest individual detractors from relative performance for the quarter.

Portfolio weights, as a percent of equity, for the positions mentioned were: Phison Electronics (0.4%), Alibaba (0.3%), SK Hynix (0.0%), Nokia (1.2%), Sumitomo Electric (0.8%), Banco Bilbao (2.0%), AstraZeneca (0.0%), Bandai Namco (0.6%), 3i Group (1.1%), and Prosus (1.1%).

## PRODUCT OVERVIEW

The Strategy seeks to generate total return greater than that of the MSCI All Country World ex-U.S. Index.

The philosophy that underlies all of GMO's Asset Allocation investment strategies is the belief that, at times and in the short term, the pricing of asset classes can deviate from true intrinsic value, but mean reverts to appropriate valuation levels over the long term. Using GMO's 7-Year Asset Class Forecasts, the Strategy seeks to allocate to areas of the global equity markets we believe are most attractively valued. Our approach combines the best of GMO's top-down Asset Allocation views and bottom-up equity research to identify mispricings at both the asset class and individual security levels. The Strategy allocates to equity strategies that are actively managed by other GMO investment teams with expertise and experience in security selection within their respective markets.
