MAJOR PERFORMANCE DRIVERS

Global markets diverged again in the first quarter of 2025, with developed markets outside the U.S. posting the strongest returns and the U.S. underperforming the rest of the world, a reversal of the pattern seen in the fourth quarter of 2024. The environment was characterized by continued trade policy uncertainties and shifting investor sentiment.

In the first quarter, the MSCI World ex USA Value index outperformed the MSCI World ex USA index by 4%. In this environment the stocks we identified as "deep value" fared well and outperformed their slightly less cheap "shallow value" counterparts, contributing to portfolio outperformance.

Outperformance was driven primarily by stock selection across a broad range of countries and sectors, with incremental value added from country allocation. Financials stock selection was a highlight, including overweight positioning toward Spain and France Financials. Selections in Health Care, Energy, and the United Kingdom were also notable contributors.

Stock selection in Japan was a challenge, including a mix of overweight positioning in Industrials and underweight positioning toward Financials. Overweight positioning toward Consumer Discretionary names also detracted, including holdings in automobile and related component manufacturers.

PRODUCT OVERVIEW

The GMO International Opportunistic Value Fund seeks to generate total return by investing primarily in international equities. The Fund measures its performance against the MSCI World ex-U.S.A. Value Index.

The Fund aims to profit from our Asset Allocation team's top-down insights as to the most attractively valued segment of developed markets outside the U.S. Currently, the team finds developed, non-U.S. "deep value" (cheapest 20%) stocks to be unusually cheap relative to their own history. This actively managed Fund concentrates exposure in the deep value segment by focusing on the international stocks that GMO's Systematic Equity team identifies as the most undervalued, using proprietary valuation models because we believe that relying on reported financials and index definitions of value may lead investors to misjudge the opportunity.
