MAJOR PERFORMANCE DRIVERS

Index Performance

Corporate credit spreads faced a turbulent start to the second quarter following President Trump's sweeping tariff announcements, which unsettled markets and raised fears about a slowdown in growth and rising goods inflation. However, the administration's decision to push out deadlines on trade deals reversed much of the initial selloff. Throughout the quarter, labor market data was constructive, and inflation stayed well-contained despite tariff adjustments, creating a supportive backdrop for investment grade corporate bonds.

The asset class delivered excess returns of 1.0%, further boosted by the move lower in yields, resulting in a total return of 1.8% for the quarter. The rally was most pronounced in the BBB-rated cohort, where credit spreads tightened 12 basis points. Across sectors, credit spreads within Communications narrowed the most, while Financing companies lagged. Credit curves flattened and the 10+ year maturity segment generated notable excess returns.

Portfolio Returns

The Systematic Investment-Grade portfolio delivered positive alpha in the second quarter. Valuation-based signals were the primary driver of relative returns, while momentum and company fundamental indicators detracted. Credit selection was strongest within the Consumer Cyclical and Energy sectors, however an overweight to the Communications sector hurt from an allocation perspective.

The ETF aims to deliver similar fixed income exposures to that of the benchmark, while owning a more liquid set of corporate bonds.
