MAJOR PERFORMANCE DRIVERS

The J.P. Morgan EMBI Global Diversified (EMBIG-D) benchmark returned -1.3% in the first quarter of 2026. During this period, the benchmark's spread over Treasuries widened by 35 bps, finishing at 289 bps, resulting in a -1.3% spread return. Meanwhile, the 10-year Treasury yield rose by 15 bps to 4.32%, leading to a 0.0% interest rate return.

The portfolio experienced positive alpha from both country and security selection during the period. Within country selection, an overweight position in Venezuela (+46.4% total return) significantly contributed to alpha. Additional positive impacts came from overweight positions in Gabon (+10.2%) and Ecuador (+0.8%). Conversely, the portfolio's overweight positions in Egypt (-6.8%) and Ukraine (-8.5%) detracted from country selection alpha, while its underweight position in Panama (+0.2%) also contributed negatively.

In the in-index security selection category, Venezuela was the overwhelming source of positive alpha, along with smaller contributions from Peru and Brazil, whereas Mexico and Colombia detracted. Among off-benchmark countries, Tunisia and Thailand contributed positively to alpha, while South Korea detracted. In the quasi-sovereign category, Venezuela and Brazil were key positive contributors, while Mexico and India detracted from alpha.

At the end of the period, the portfolio's largest overweights are Venezuela, Argentina, and Turkey, while the largest underweights are Indonesia, China, and Malaysia. During the period, the portfolio saw a notable shift in Brazil and Mongolia, transitioning from underweight to overweight positions. Additionally, the underweight position in the United Arab Emirates decreased. Conversely, the portfolio reduced its overweight positions in India and Ecuador, while the underweight position in Panama increased.
